Subject-7th Customs Clearance Facilitation Committee (CCFC) meeting with Officers/stakeholders-reg.

In reference to the Circular No. 21/2025- Customs dated 12.09.2025 issued by CBIC, it is informed that the next meeting of Customs Clearance Facilitation Committee (CCFC) is **scheduled for 31.10.2025 at 03:00 PM in Room No. 103, 1st Floor, New Customs House, Near IGI Airport, New Delhi-110037** under the Chairpersonship of the Chief Commissioner of Customs (Preventive), Delhi Zone.

2. In this regard, it is requested to kindly provide inputs/comments on the following agenda points in terms of Circular No. 21/2025-Cus dated 12.09.2025:

(i) Ensuring and monitoring expeditious clearance of imported and export goods in line with the timelines prescribed by the parent Ministry/Department concerned.

(ii) Identifying and addressing bottlenecks, if any, for streamlining and easing the Customs clearance process of imported or export goods.

(iii) Conducting Time Release Studies (TRS) with a view to improving the clearance time of imported and export goods.

(iv) Holding internal consultations to expedite the clearance process of imported and export goods and recommending best practices for policy consideration of CBIC and concerned Ministries/Departments/Agencies.

(v) Resolving grievances of importers, exporters and members of trade/industry relating to the clearance process of imported and export goods, and flagging unresolved issues or issues involving policy implications to the NACs or the Board, as appropriate.

(vi) Ensuring and monitoring effective implementation of action points and agenda items under the National Trade Facilitation Action Plan (NTFAP).

(vii) Conducting a study through a Zonal-level working group on facilitation measures, innovation and technology, capacity building, gender participation, etc., and sharing the

corrective measures/suggestions derived from the study with the Board to further enhance EoDB.

(viii) Proper monitoring and effective implementation of existing grievance redressal mechanisms (TSKs, AEM, ICEGATE Helpdesk, etc.).

(ix) Outreach to the trade regarding new trade facilitation and EoDB measures.

Further, any other agenda points as per CCFC mandate including the above points for the said meeting may please be forwarded to this office **latest by 06.10.2025**, preferably in word format through e-mail (**cccpdz-cbec@gov.in**). Subsequently, these points shall be taken up for discussion/deliberations during the said meeting with the permission of the Chair.

3. Further, in pursuance of the circular no. 02/2014-Customs dated 08.03.2024; kindly encourage representation of women in the upcoming Customs Clearance Facilitation Committee (CCFC) via their presence and inclusion of agenda points from their perspective.
